An Intellectual Property Right Cell is constituted in our Institute under the Chairmanship of the Principal to coordinate the activities pertaining to the Intellectual Property of the Institute and oversee the filing of patents by Faculty/Staff/Students of the Institute including copyrights and other issues.

The main objective of the IPR Cell is to help generate new ideas, develop new process technology and to provide absolute protection. The responsibilities of IPR Cell are:

- ✓ To create awareness on IPR through conducting seminars, conferences, invited talks and lectures, and training programs among the faculty members and students of MIFT
- ✓ To impart training on forthcoming endeavor's regarding patent filing processes.
- ✓ To create an opportunity for New Product development and Commercialization.
- ✓ To safeguard the intellectual property against unauthorized use.
- ✓ To provide incentives to inventors in the form of professional recognition and financial compensation.

In MIET, Intellectual Property consisting of Patentable or Copyrightable material can be created in the following three ways:

- a. Institute undertaking an assignment either from an external agency or by its own decision to take up creation of a specific Copyrightable or Patentable material and assign a team of its faculty members/researchers/students to accomplish it.
- b. Individual or a team of faculty members/researchers/students may develop copyrightable or patentable material during the course of their study, research or as a Project.
- c. An external agency, be it a Trust, Industry, Commercial undertaking or a Company may enter into a specific agreement with the Institute to develop some specific Copyrightable or Patentable material.

In MIET, the creator of the intellectual property shall

- arrange for the retention of all records and documents that are necessary to the protection of the intellectual property.
- cooperate with the IPR Cell in drafting the patent applications to be filed with the competent government agencies

Institute Research	means any research or development activity which is
	undertaken by the Institute, or which is related to duties and
	responsibilities for which a person is compensated by the
	Institute, or which is conducted with substantial use of Institute
	facilities, or resources.
Invention Disclosure	means a written description of an invention that is confidentially
	made by the inventor.
